# We are TNDC

Tahltan Nation Development Corporation (TNDC) – the business arm of the Tahltan Nation – is owned by its shareholders – Iskut Band, Tahltan Band and Tahltan Central Government. A portion of TNDC's profit is returned to our shareholders in the form of a dividend for initiatives to benefit Tahltan members, while the remaining amount is retained for working capital and to be reinvested for future growth.


TNDC was founded in 1985 by visionary, progressive Tahltan leaders who wanted to ensure the Tahltan Nation benefits from the economic activities and development occurring within Tahltan Territory and to provide employment, training and contracting opportunities to Tahltan members. TNDC's founders were Jerry Asp, General Manager of TNDC, Pat Etzerza, Chief of the Iskut Band, Vernon Marion, President of Tahltan Tribal Council and Ivan Quock, Chief of the Tahltan Band.

From its roots in residential construction, TNDC's services have expanded to heavy construction, earthworks, camp services, air support, aviation, forestry, transportation and fibre-optic communications services.

In the 2021–2022 fiscal year, TNDC's gross revenue was \$70-million with \$80-million in assets. In the 2022 work season, employment peaked at 319, with more than 500 employed throughout the season, and 71% of the workforce identifying as Indigenous.

With the volume of work and TNDC's growth, we hit a recruiting milestone, hiring more than 500 employees throughout 2022 and our seasonal peak hit 319 personnel.

#### **IDENTIFY AS INDIGENOUS**

Of those hired, 71% were Indigenous and 34% were Tahltan and Tahltan Associates.

**PEAK EMPLOYEES**  In 2021 TNDC was rated by Business in Vancouver the biggest First Nations business in B.C. and was rated #3 for 2022. In 2022 TNDC received the Indigenous Business of the Year at the 5th Annual Arctic Indigenous Investment Conference and was named to the INDIGENOMICS 2022 10 To Watch List. We were welcomed as a new member of the Canadian Chamber of Commerce and Canadian Council for Aboriginal Business, and became the only Indigenous corporation in Canada to have a board position on both organizations. In addition, we have been a member of the BC Road Builders & Heavy Construction Association since 2018.

In 2022, we presented at several key conferences sharing TNDC's success story. These included Indigenomics Institute, Arctic Indigenous Investment Conference, Prospectors & Developers Association of Canada, Canadian Institute of Mining, Metallurgy and Petroleum Convention, Nation2Nation Forum, and Mining Suppliers Association of BC Professional Education Forum.

TNDC's goal is to be the **Indigenous Partner of Choice** – an integrated full-service provider and trusted partner to our clients. While we are working to diversify our business, exploration and mining continues to be the primary industry we serve, and construction and camp services our core operations.



TNDC serves the resource exploration, mine development and mining, building construction, forestry, hydroelectric power, civil, infrastructure and public works sectors.

TNDC brings value to our clients with local knowledge, operations, personnel and equipment. To expand our service capabilities, we have partnered with more than 20 industry leaders providing a comprehensive range of services, who are leaders in their sector. This enables us to combine our respective strengths and capabilities, benefitting TNDC, our partners and our clients.



We are fortunate to work with several clients who are supportive of TNDC and this approach, including Skeena Resources on its Eskay Mine project and Seabridge Gold on its KSM and Johnny Mountain Mine projects. Our largest client is Newcrest Mining Limited, which operates the Brucejack and Red Chris mines.

Together with our partners, the scope of services TNDC is providing at Red Chris includes crew transportation by air charter and highway coach, camp services, tailings impoundment area construction, underground mining portal exploration, underground explosives, geotechnical drilling and concentrate hauling. At Brucejack, our Tahltan Procon Joint Venture provides all underground tunnel development, ground support and production: ore haulage, underground construction, electrical installations, and backfill placement services.



- Employee Survey: In April we held our first-ever employee survey.

   We gained excellent insight that helped us better understand where our efforts should be focused.
- Employee Townhall: We introduced
   *Employee Townhalls*, the first held in

- Employee Manual Rollout: In July

#### PERFORMANCE MANAGEMENT

- Performance Reviews: A new performance review process was implemented for new and existing employees. 


#### TRAINING & DEVELOPMENT



### I FINANCE & ACCOUNTING

### TNDC IS BUILDING A TIER 1 FINANCE & ACCOUNTING DIVISION

Finance and Accounting intersect all areas of our business. Significant effort is being made in Finance and Accounting to ensure we address the needs of our business today and support our growth into the future.

We are establishing new and elevating existing practices, procedures, reporting and systems to meet the requirements of the Tier 1 companies we work with, financiers we depend on, and shareholders we report to. In 2022, we focussed on several initiatives aligning with four key priorities.



#### **IMPLEMENTATION OF NEW POLICIES AND PROCEDURES**



#### **INTERNAL CONTROLS**

TNDC engaged a third-party accountant to complete an initial review of all our financial processes, including Accounts Receivable (AR), Accounts Payable (AP) and payroll. Once completed, we will develop a plan to strengthen financial controls.



#### **PAYROLL**

Significant work has been completed on payroll, focussing on issuing electronic pay stubs, reducing error rates, and ensuring compliance. This will continue to be a focus moving forward to ensure we streamline the processes while reducing errors.

#### **ENHANCING FINANCIAL TRANSPARENCY**



#### FISCAL YEAR CHANGE

TNDC's fiscal year used to run from April 1st to March 31st, spanning calendar years. This did not meet the timeline reporting requirements of our Shareholders. As a result, we undertook the process to change our fiscal year to run from January 1st to December 31st. We received approval from TNDC's Board of Directors to make the change and completed the accounting paperwork to make the necessary amendments. The fiscal year change will begin January 2023.



#### **AUDIT REVIEW**

Audited financial statements are an important final step in the accounting process, to verify accuracy of our company's financial status, supporting easier and accelerated access to financing and capital. Having audited financials will also provide us with the financial reporting required to be bonded (which provides an added level of financial security to lenders) in the future. We have made excellent progress towards an audit review and are aiming for our first audit to be completed for the December 31, 2023 year end. TNDC is pleased to report that our financing partners have written this into their financing agreements to support future access to capital.



#### INTRODUCING A FINANCE, AUDIT AND RISK COMMITTEE



#### FINANCE, AUDIT AND RISK COMMITTEE

A Finance, Audit and Risk Committee is now supporting the TNDC Board in fulfilling its oversight responsibilities of the financial reporting process, the audit process, internal controls, compliance with laws and regulations, risk mitigation, and mitigation oversight. We are in the process of building a calendar to support regular reporting that aligns with quarterly board meetings.

#### What does 2023 have in store?

In 2023 we are maintaining our focus on the same priorities of 2022. While we made good progress in establishing and implementing the fundamental practices, procedures, reporting and systems needed, the complexity of these initiatives requires more than a calendar year to fully execute.

- Implementing new policies and procedures to support quarterly reporting, create a more robust accounts receivable, streamline payroll, and enhance integration with all areas of our business.
- Enhancing financial transparency to provide better access to capital financing (to assist with our growth and better plan for the future) and improve shareholder reporting (to meet their annual reporting requirements).
- Establishing a comprehensive budget process that is managed throughout the year to better track costs and expenses, in turn better serve our clients, employees and financers.
   Gaining greater understanding of our financial numbers will also allow us to develop more profitable contracts in the future.
- Quarterly reporting to the board on planned to actual (budget), including the creation of a financial dashboard to make financial information more understandable and transparent for the board and shareholders.

### OPERATIONS

The goal and commitment of TNDC Operations is to be a trusted partner to our clients, providing quality services safely, on time and on budget.

TNDC Operations is responsible for Health, Safety and Environment (HSE), Construction, and Fleet Management and coordinates our crews and equipment to carry out our contract commitments across our project sites.

#### **OPERATIONS AT A GLANCE**

- Health & Safety: Hired a new HSE
   Director. In the process of obtaining full
   COR certification. New programs to
   promote employees safety performance
   and mental health awareness.
- Construction: Heavy construction and earthworks across projects including: TIA Construction at Newcrest Red Chris Mine, Eskay Creek Revitalization Project, KSM Mining Access Road and Dease Lake Airport upgrades.
- Fleet Management: Workforce, equipment and inventory management systems expanded. Fleet poised to surpass 250 pieces and growing.
- Camp Services: Increased focus on training, development and wellbeing of employees. Wages and travel accommodation benefits increased and launched a TNDC-Sodexo apprentice program.

### **HEALTH & SAFETY**

The health and safety of our employees and everyone we work with is our top priority. Our target is zero accidents, injuries, incidents and near misses – to ensure everyone goes home safe every day. In 2022 TNDC continued introducing several safety programs and initiatives, concentrating on training, prevention and reduction, to reinforce our **SAFETY FIRST, SAFETY ALWAYS** mindset. We hired a new HSE Director to lead TNDC in executing on our HSE priorities.

#### **COR CERTIFICATION**

TNDC is in the process of obtaining full COR certification. The WorkSafeBC Certificate of Recognition (COR) program recognizes and rewards employers who voluntarily go beyond the current legal requirements, implement an effective occupational health and safety management system, and pass a certification audit to the standards set out by the WSBC Board.

Attaining COR will enable TNDC with health and safety industry leaders and enable us to work outside Tahltan Territory. In 2022 we undertook several initiatives to align our safety management system with COR, preparing for a successful certification audit. These include revising our HSE policy and manual and introducing Lighthouse, a cloud based HSE system, to digitize documentation records tracking.

#### SAFETY PROGRAM ENHANCEMENTS

- The TNDC HSE Team has expanded better serve our operations and we have added equipment trainers with designated roles to expand site-based training.
- TNDC has introduced HSE Spot Awards, as part of the HSE Recognition Program, to recognize and reward positive safety behaviour.
   These were rolled into the new TNDC Rewards and Recognition Program introduced in October.
- TNDC has increased participation in the "Why We Work Safe" program, to remind employees that a workplace accident or illness affects not only us, but also our loved ones left behind – parents, partners, children, and pets.
- TNDC has enhanced mental health first aid awareness and participation among employees, for those in need.



#### **COMPLIANCE & COMPETENCY**

- TNDC has implemented a Digital Action
   Tracking System (DATS), which is a training compliance tool for all new hires coming to our Red Chris project site.
- TNDC has introduced a Verification of Competency Program for use of new equipment. The purpose of this program is to ensure an employee's skills and ability are satisfactory, to prevent incidents and injury.
- TNDC has rolled out a new TNDC Winter Preparedness Summit 2022, which included proactive health and safety preparation and personal protective equipment (PPE) requirements.
- TNDC has increased participation in Newcrest Mining's NewSafe Behaviours Program, which guides employees through a workplace safety risk assessment, communication and action process.

#### **SAFETY PERFORMANCE**

We are please to report that we have implemented Phase 1 of TNDC's Corporate Loss
 Prevention Program, which targets zero workplace accidents and injuries (reducing incidents). This program has improved our safety performance and resulted in a reduction in our WSBC Insurance Premiums.

#### What does 2023 have in store?

The road to health and safety is a continuous journey that requires the commitment of every member of the TNDC team. Strengthening our safety culture, improving our safety performance, and ensuring everyone goes home safe is our relentless focus. In addition to continuing implementing initiatives to reduce and prevent incidents, heighten risk awareness, and encourage positive behaviour, we will be focussing on three key priorities:

- Achieving COR Certification (targeting fall 2023), in conjunction with finalizing the revised HSE Manual.
- Implementing an Employee Safety Training Program, using external trainers, Train the Trainer, and simulator systems.
- Executing complete digitalization of the HSE process with Lighthouse.

### CONSTRUCTION

In 2022, TNDC's Construction Division managed heavy construction and earthworks on the following key projects this past season:

- » TIA Construction at Newcrest Red Chris Mine
- » Eskay Creek Revitalization Project
- » KSM Mining (Seabridge Gold) Coulter Creek Access Road (CCAR)
- » Regional Projects (Dease Lake Airport Upgrades)

#### **RED CHRIS**

TNDC's Red Chris construction team completed a busy and successful season with an impressive performance, solidifying TNDC as a trusted partner to Newcrest. We employed roughly 85 employees on two crews, working two-week rotations on day and night shifts.

The 2022 season has been the most successful in the history of the tailings impoundment area (TIA construction), completing quality work safely, on time, on budget, and fully staffed. The project operated safely from the beginning of winter works in early 2022, when our crews carried out TIA de-risk work (clearing and construction of access roads and priming extension areas), in preparation for the TIA dam construction, through to the completion of the construction, which started in early May and wrapped in mid-October, with construction compliance.

> TNDC Construction supported several other projects for the Red Chris site: ongoing underground development (with Barminco), early works drilling of ventilation raise holes, the Newcrest environment investigative drilling program, and east ditch water collection repairs and maintenance. We also continued support of capital projects, service maintenance and exploration.

TNDC has been supporting Newcrest dam construction projects in preparation for the 2023 season, which promises to be as busy as 2022. We have requested to be at the Newcrest table for planning sessions for safety improvements and construction planning.





#### **ESKAY CREEK REVITALIZATION PROJECT**

TNDC had another successful year at the Skeena's Eskay Creek Revitalization project, providing Road Maintenance and Camp Services. Our equipment fleet throughout the summer included a grader with packer, a wheel loader, an excavator, a skid steer loader, a dump truck and support light vehicles. TNDC is responsible for the maintenance of 23 kms of, steep, winding, mountainous, industrial road to the Eskay Creek Revitalization Project Minesite.

- Our road maintenance duties in summer included drainage ditching and culvert installation, surface grading and compaction, load, haul, and placement of crushed aggregate for surface improvement.
- Our winter program started in late October, changing our equipment fleet to add an additional grader and an additional wheel loader.

#### **SEABRIDGE CCAR**

The Coulter Creek Access Road (CCAR) project, working with our partner Pelly Construction, completed 1,300 metres and did significant improvement to the road surface of the 2 km of road built in the 2021 season. This included approximately 300 cubic metres of crushed gravel imported to site and placed by TNDC equipment and operators.

We had up to 14 personnel and 12 pieces of equipment and light vehicles, as well as a 12-passenger bus to transport crews from camp to the project site, supporting this project.

- · Construction activities started in late July with extensive snow removal and surface improvements. We continued with culvert installations and extensive environmental and sediment control installations. Hundreds of sediment dams and silt fences were installed on the 1.8 km of roadbed pioneered in the previous season.
- The TNDC and Pelly teams worked hard to ensure the environment was protected in the event of rainstorms. Stringent environmental measures were placed on our client for this project, and where construction activities during heavy rain caused soil disturbances that fell outside of the requirements, our crews stopped work to address environmental issues.

#### **DEASE LAKE AIRPORT UPGRADES**


The TNDC team at Dease Lake completed airport upgrades and construction deficiencies, completing the remaining capital projects taken on over the last two years. Our crews then transitioned to support winter operations at the airport.

#### FLEET MANAGEMENT

Together with personnel, our equipment fleet is one of our most valuable assets, and having reliable operational equipment is vital to delivering on client contract commitments.

Our Current Fleet count is poised to surpass 250 pieces and continue to grow.

- We implemented a fleet inventory management program to change out 20% of our equipment annually (replace and/or add new units).
- Our Dease Lake Mechanical Shop facilities are a fully functioning repair shop, supporting our equipment operations. We have two full time mechanics working at the shop who have carried out several large critical repairs.

#### What does 2023 have in store?

TNDC has a great reputation for road construction, exploration, heavy earth moving and mine support services. To enhance this strength, and position TNDC for long-term profitable growth, TNDC Operations is focussing on four priorities:

- Strengthen our business and culture fundamentals to enable profitable growth: implementing business procedures, processes and workflows across departments, and project cost management to establish consistent cost predictability, manage risk and ensure quality.
- Build and train a sustainable team: investing
  in our people resources through training,
  development and mentorship, to grow capability and capacity from entry level new hires
  to supervisory and mid-level management,
  and develop leaders with the business knowledge and accountability. Refocusing efforts to
  employ Tahltan owned businesses and direct
  service providers where work is available.
- Pursue best in class solutions that make us
  a preferred choice: strengthening client relationships to align TNDC business processes,
  working with clients to plan for construction season work contracts, and develop
  packages that ensure resources/equipment
  are available and utilized effectively, with
  flexibility to advance onto new opportunities.
  We are also building the capacity to perform
  fixed price contracts, not just time and materials, which better aligns with TNDC's the
  services TNDC provides.
- a high-level business plan to grow existing sector participation and identify diversification opportunities, implementing construction management software, protocols and processes to support accurate contract estimation and execution, and strengthening business partnership management to foster synergies, accountability and revenues.

### **CAMP SERVICES**

Camp Services is delivered through our 20-year TNDC-Sodexo partnership, staffing and payroll is through TNDC while Sodexo manages service delivery. We have been providing comprehensive camp and food services to the Newcrest Red Chris Mine since 2012 and Skeena Resources' Eskay Creek Revitalization Project since 2020.

In 2022, we increased our focus on the training, development and wellbeing of our employees to support recruitment and retention. We increased hourly wages and travel and accommodation benefits, launched a TNDC-Sodexo apprentice program, and refreshed TNDC/Sodexo branded uniforms. Sodexo also introduced a new Sodexo employee rewards program (which complements TNDC's Employee Rewards and Recognition Program introduced in October 2022).

At Newcrest's Red Chris Mine, we provide year-round housekeeping, laundry, janitorial, catering, retail, front desk/reservations and site management. In 2022 we employed 127 employees, on day and night crews, working 2-week rotations. Additional buildings were added by Newcrest to the scope of our service delivery (dorm, administration and external); with four new dorms adding 178 rooms in the final stage of commissioning.

In 2023, the focus will remain on training, development, recruitment and retention, while serving an expanded camp. We will be adding additional HR support and rolling out a Culinary Apprenticeship Program, in collaboration with Coastal Mountain College. On the operational side we will be working closely with Newcrest on site development and new camp evaluation, continuing investment in solution orientated equipment and automation, and rolling out a sustainable reusable container, cup and cutlery program (to reduce single plastic waste).

At Skeena's Eskay Creek Revitalization Project, we are providing seasonal housekeeping, laundry, janitorial, catering, front desk/reservations and site management. During the 2022 work season we employed 26 employees, on day and night crews, working on 2-week rotations.

### DRIVING VALUE AND ACCOUNTABILITY FROM OUR BUSINESS PARTNERSHIPS

TNDC's Business Partnerships Department is critical to the establishment, management, and success of our partnerships, which must bring financial and social value to TNDC and the Tahltan Nation. Our Business Partnership Department, therefore, is critical to TNDC's revenues and reputation.

In recent years TNDC has changed its approach to new partnerships, establishing shorter term Collaboration Agreements that are simpler from an administrative perspective and more flexible than traditional joint ventures, while supporting enhanced accountability and reporting.

### PARTNERSHIP MANAGEMENT PROGRAM


TNDC is committed to strong environmental, social and governance practices, working with Tier 1 clients requires as much. In addition, TNDC is committed to an enhanced, structured, and robust program to not only assess potential partnerships but to manage our partnerships throughout their life cycle.

As a result, we have introduced a new *Partner Management Program* that is designed to improve accountability and transparency, establishing a vigorous screening process for entering partnerships, and a standardized process for managing each partnership throughout the year.

#### What is the Partnership Management Program about?

- Partnership Screening Processes: TNDC now has a screening process that is designed to ensure our prospective partners have acceptable Health, Safety and Environment (HSE) standards, and they undertake their operations with ethical and conscientious standards. The assessment includes a review of their HSE practices and compliance as well as their financials to ensure they are in good fiscal standing. We request references (from clients and industry partners) to verify their ethics, HSE compliance and appreciation of Tahltan values. Lastly the process includes a risk assessment to avoid risk in these areas for TNDC.
- Partnership Management: Once partnerships are formed, TNDC now has a structure in place that includes revenue forecasting, quarterly meeting schedules, reporting structures and financial reporting criteria, as well as safety programs and statistics reporting to ensure ongoing compliance. Our new structure also sets expectations for and measures against Tahltan employment and Tahltan owned business engagement.
- Partnership Review Assessment: TNDC is undertaking a
  comprehensive review of all existing partnerships to assess
  the fiscal and social value they have provided to TNDC
  and the Tahltan Nation. In addition to screening out poor
  performers or partners that may not share Tahltan values,
  this review will ensure all our partners meet the standards
  of our new Partnership Management Program.

### YDL DEASE LAKE AIRPORT – TNDC CONTRACT OPERATOR, UNDER THE DIRECTION OF THE STIKINE AIRPORT SOCIETY

In March 2021, TNDC signed a contract with the Crown Land lease owners Stikine Airport Society (SAS), to become the contract Airport Operator for the Dease Lake Airport (YDL) through 2024.

TNDC Airport Services is responsible for inspections, maintenance, and the ongoing operations of the airport. We conduct snow clearing, brush clearing, runway friction tests, runway sweeping, grounds maintenance, passenger handling, ground handling of aircraft and de-icing of aircraft.


This past summer saw many of the capital projects taken on over the last two years completed. The SAS is approaching the final sign off with the contractor on the Airport Improvement Project (AIP), which is almost complete. The Dease Lake Airport now boasts updated operations and safety manuals, an updated lighting system, complete runway


and taxiway resurfacing, new turn pads and blast pads at the ends of the runway, apron expansion, partial fencing, backup generator, new parking lot, new signage, and mandatory obstacle clearance of surrounding trees.


Hazard lighting on the terrain in the airport vicinity was also upgraded, separately from the AIP. This will immensely improve dispatch reliability for night operations into YDL, especially for medevac aircraft. Collectively, these improvements support YDL's efforts towards achieving federal certification.


In collaboration with the SAS, TNDC has completed the installation of a fuel tank close to the main apron and has secured a fuel provider for the airport. This will stabilize a major piece of aviation infrastructure in the Territory with a focus on supporting all users with a high quality, competitively priced supply of Jet A fuel.



#### **EXECUTIVE FLIGHT CENTRE PARTNERSHIP**

TNDC is very excited to have partnered with Executive Flight Centre (EFC) to assist with TNDC's journey of achieving Federal certification. EFC and their associated companies have extensive experience in remote airport management, fueling and fuel systems, logistics, and airport development.

EFC is providing onsite leadership with oversight and development of the airport and TNDC crews. They bring over 50 years of aviation support expertise and a library of high-quality training systems. This will accelerate the development of TNDC Airport Services and its ability to quality manage to high aviation standards. Most importantly, EFC will provide hands-on mentoring of our airport personnel to develop future experts and leaders in airport operations.

Our shared goal is for the eventual phase out of EFC in favour of a Tahltan led Airport Services division. Aviation expertise is learned like any other discipline, and we see this partnership as a means of supporting our people for success.

#### YDL DEASE LAKE AIRPORT IN PROCESS OF FEDERAL CERTIFICATION

Why Is Certification Important?

- Certification will allow for the federal funding necessary to provide for:
- Ongoing maintenance of runway and lighting
- A future Airport Maintenance Building for airport operations
- A future helicopter landing pad
- Fencing around the rest of the airport
- Certification will allow for Dease Lake Airport to be a base for Emergency Management for Northwest BC.
- Certification will allow for the possibility of scheduled service, which opens the possibility for daily mail delivery and a regular rotation of out-of-town medical professions, to name just a couple.

### PREMIER JOHN HORGAN OPENS **UPGRADED DEASE LAKE AIRPORT**



Former premier John Horgan made a historic visit to Tahltan Territory in June, being the 1st premier to visit the Territory in 30+ years. Bringing high-speed fibre optics telecommunications services into Tahltan Territory.

The vision to provide high-speed fibre optic communications to Tahltan communities and businesses in Tahltan Territory began more than a decade ago, with negotiation of fibre optic strands built into the BC Hydro Northwest Transmission Line (NTL).

Since the NTL was energized in 2014, TNDC has remained committed to the vision. TNDC has been working behind the scenes to secure federal and provincial government funding, then design build planning and permitting, as well as establishing a strategic partnership to execute the build.

Construction of the high-speed telecommunications services with fibre optic technology is being carried out through Tahltan Communications - a partnership between TNDC and CityWest Tahltan Communications is building over 200 kilometres of new fibre optic cable in unison with fibre optic strands that are part of the NTL.

The conduit that carries the fibre has now been built for 110 of the 200 kilometres. The conduit will need to be filled with the fibre optic strands, and there are several steps before it is lit up. But good progress has been made despite the remote and challenging work conditions.

Tahltan Communications is working towards providing high speed Gigabit connectivity to Iskut and Dease Lake in 2023. Getting it into homes and businesses which will happen in two steps. First is the backbone fibre that travels from the south at Kitwanga up Hwy 37N (inside the NTL) all the way north to Dease Lake. Second is the fibre that travels to a home base, where we build a system through the community to serve customers like schools, Band offices and firehalls. After which, we then build to homes.

This \$13 million project will also provide high speed fibre optic-based telecommunications services to the many small, medium and large industrial businesses in Tahltan Territory (later in 2023). This state-of-the-art fibre-optic network will bring significant benefits to Tahltan Territory, improving the delivery of healthcare, safety, education and social services, and fostering economic development, environmental protection, and infrastructure development.

#### **BACKGROUND**

- Tahltan Territory an area equivalent of 11% of British Columbia - is without high speed internet technology, restricting business activities, education and health innovation opportunities.
- The Tahltan Nation was provided fibre optic strands on the Northwest Transmission line through its agreement with BC Hydro and the Province in 2011.

#### **ADVOCACY**

 Tahltan Central Government, Iskut Band, Tahltan Band and TNDC - Advocated to bring high speed internet to Tahltan Territory.

#### **ACTION**

 TNDC applied for funding though the Government of Canada's Connect to Innovate Program and British Columbia's Connecting B.C. program. This project has been supported through funding from the federal and provincial governments. Funding for the project was announced July 2, 2019.

• TNDC has been working on build planning and permitting since funding was announced, leading up to the start of construction on May 31, 2022.

#### WHAT DOES THIS MEAN?

- This state-of-the-art fibre-optic network will bring significant benefits to Tahltan Territory, improving the delivery of healthcare, safety, education, and social services and fostering economic development, environmental protection, and infrastructure development.
- Reliable, high speed fibre optic communications will open the door to new technology-based business ventures that create exciting new career opportunities for Tahltan members.

#### WHAT DOES THE FUTURE HOLD?

- Once construction is complete, Tahltan Communications can provide last mile fibre optic connectivity to community households and businesses.
- · We are awaiting a Federal and Provincial Universal Broadband Funding announcement for last mile connectivity for the communities of Iskut and Dease lake.
- The fibre optic communication network will enable Tahltan Communications to investigate better connectivity solutions for Telegraph Creek.

### I TAHLTAN FORESTRY





Tahltan Forestry Limited (TFL) is a joint company, owned by TNDC and NorthPac Forestry Group Ltd. TFL was founded in late 2019, with the purpose of managing all forestry-related activities in Tahltan Territory.

Tahltan Forestry has two main streams of activity:

- 1. traditional logging; and
- 2. forestry work for mines and utilities.



#### TRADITIONAL LOGGING

TFL is now operational on the Tahltan First Nation Woodland Licence (FNWL). The FNWL is a forest licence that provides exclusive access to the non-overlapping portions of the Tahltan Nation Territory. TFL is currently harvesting two cutting permits to the southeast of Bob Quinn. The blocks contain a mix of hemlock, balsam, spruce, and pine. Given the range of both quality and species, the logs will be sold to numerous customers. These customers include sawmills in Smithers and Houston, pulp mills in the Lower Mainland, and log buyers in Asia.

TFL is continuing with the development of additional cutting permits in the corridor between Bob Quinn and Willow Creek that will be harvested in 2023.

#### **FORESTRY WORK**

Tahltan Forestry has been active working for mines and utilities. Some of the projects TFL has worked on, or will be working on include:

- Stikine Airport Society Dease Lake Airport Clearing
- BC Hydro Treaty Creek Substation Clearing and Access
- Skeena Resources Eskay Creek Revitalization Project and Substation Clearing
- KSM Transmission Line Clearing

Tahltan Forestry has had the benefit of working with a number of highly skilled Tahltan businesses on the projects listed above. Some of the companies we have worked with, and the scopes performed include:

Tahltan Forestry started work on the KSM Transmission Line Clearing in November 2022 and expect to be busy on the site through 2023.

We currently do not directly employ any Tahltans. All positions in the Territory are posted through Tahltan Central Government's OnTrack Platform. To attract Tahltan employees we have explored basing trucks in Iskut to service Red Chris, recognizing that all units are currently based in Stewart and travel may present a barrier.

Recently we have been approached by and entered into preliminary discussions with a young entrepreneurial Tahltan who was previously an employee. He is interested in purchasing his own truck and hiring on as an owner operator. We are excited about this opportunity and look forward to supporting this individual as he develops his business plan with hopes of working for the partnership as a contractor. Coming out of COVID, community engagement and connections are going to be a focus to engage with more individuals where they are.

Over the last ten years we have developed robust "new driver training programs" to support the next generation of professional drivers, and hope that through community engagement we can provide this option to more Tahltans who otherwise may not have been aware of it.

#### WHAT WERE THE SIGNIFICANT ACHIEVEMENTS OF THE PARTNERSHIP IN 2022?

Formed in 2022, the ATCO-TNDC partnership was successfully awarded the supply of a 120-person work camp complete with recreation hall, offices, kitchen and dining to Seabridge Gold's KSM Project.

HOW MANY TAHLTANS DO YOU EMPLOY? WHAT LEVEL ARE THEIR POSITIONS? WHAT STEPS ARE BEING TAKEN TO DEVELOP TAHLTAN STAFF AND CAPACITY BUILDING?

Three full time Tahltan members were employed through our mechanical/electrical subcontractors (one mechanical plumber & two electricians).

Due to the short project timeline for installing modular units, direct capacity building opportunities are limited with provision of work camp scopes of work. However, through subcontractors, sub-scopes were successfully awarded to Tahltan businesses, allowing these businesses to both retain and develop their Tahltan employees through work supporting the work camp install.

#### DO YOU HAVE ANY TAHLTAN CONTRACTORS WORKING FOR YOUR COMPANY? WHAT ARE THEY DOING ONSITE?


There are three Tahltan contractors that provided services for the Seabridge KSM Project:

### WHAT IS YOUR RELATIONSHIP WITH TNDC? WHAT SERVICES DO YOU PROVIDE IN TAHLTAN TERRITORY?

We have a long relationship with TNDC, providing weekly scheduled freight service into Tahltan Territory since the 1980's and have worked with TNDC for more than 30 years. We formalized a business relationship in 2015. We transport all the "things" that the people who live, work, and play in Tahltan Territory require and use for those activities – whether it be groceries, furniture, building supplies, Christmas gifts, tools, and mining equipment and supplies, including the parts required to keep TNDC's equipment moving.

### WHAT WERE THE SIGNIFICANT ACHIEVEMENTS OF THE PARTNERSHIP IN 2022?

We maintained regular twice weekly service to Iskut, Dease Lake and Telegraph Creek throughout 2022 despite the various challenges we experienced, including Covid 19, the floods, labour and equipment shortages, and highway closures.

### HOW MANY TAHLTANS DO YOU EMPLOY? WHAT LEVEL ARE THEIR POSITIONS? WHAT STEPS ARE BEING TAKEN TO DEVELOP TAHLTAN STAFF AND CAPACITY BUILDING?

We employ a growing number of Indigenous employees in various positions throughout our company and in 2022 were able to hire a Tahltan employee to make deliveries in Dease Lake as well as our first Indigenous female employee. Our practice is to train and promote from within so we encourage and train all our employees

to develop new skills and apply for increasingly senior roles. The Mullen Group, of which we are now part, has a formal management training program that is open to applicable employees. We continue to post positions across our network with the TCG employment office.

### DO YOU HAVE ANY TAHLTAN CONTRACTORS WORKING FOR YOUR COMPANY? WHAT ARE THEY DOING ONSITE?

We utilize the Kluachon Centre Store as our contract agent for deliveries of less than truckload freight shipping in Iskut, BC. We use several Tahltan businesses as suppliers, including KEDA Propane and TNDC. We also use the services of various TNDC partners, including the fueling services of Northwest Fuels.

#### WHAT IS THE FOCUS OR OUTLOOK FOR THE PARTNERSHIP IN 2023?

Our focus will be to grow and improve our freight service along Highway 37. We are cautiously optimistic that global security concerns will encourage the development of resource projects in Canada including the Golden Triangle, which will be of benefit to TNDC and its partners. We also hope that some of the supply chain disruptions, equipment shortages, and inflationary pressures that have created a lot of business uncertainty will continue to moderate and enable investors to confidently invest in new projects again.

### WHAT IS YOUR RELATIONSHIP WITH TNDC? WHAT SERVICES DO YOU PROVIDE IN TAHLTAN TERRITORY?

Barminco have engaged in a Collaboration Agreement with TNDC as part of our engagement with Newcrest to supply the underground mining services at the Red Chris Mine located within Tahltan Territory.

The Collaboration Agreement includes the purchase and supply of equipment. The primary scope of works to be supplied to Newcrest is the underground mine tunnelling excavation (development) and installation of all required ground support of the Exploration Decline to gain access to the Exploration Drill platforms for the future Underground Block Cave at the Red Chris Mine.

Barminco are one of the industry leaders in the method of high speed, mechanized underground development when utilizing the technique of installing ground support and drilling the blast holes, all with an underground Jumbo.

### WHAT WERE THE SIGNIFICANT ACHIEVEMENTS OF THE PARTNERSHIP IN 2022?

The significant achievement of the partnership in 2022 has been the safe and efficient completion of over 3,150m of lateral development, including 2,350m of decline development since the first ground was broken in June 25, 2021. The initial scope of approximately 3,600m of lateral development is on schedule to be completed by December 31, 2022. This is a monumental achievement in a new region with a predominantly new workforce.

Further negotiations are well underway to extend the scope of work to progress the mine further, to open up the access to the footprint of the block cave and to commence the excavation of the conveyor decline that will be utilized in the future for the ore haulage of the block cave to the mill, once underground production has commenced.

### HOW MANY TAHLTANS DO YOU EMPLOY? WHAT LEVEL ARE THEIR POSITIONS? WHAT STEPS ARE BEING TAKEN TO DEVELOP TAHLTAN STAFF AND CAPACITY BUILDING?

There are eight Tahltan and Tahltan Associates directly employed with the Barminco Red Chris team; some are new to the underground environment:

- 2 Administrators: they aid with the training department and HR function required onsite. Both have received internal training in our training database software and newly implemented HR software. Further training with an Administration Specialist from Australia early in 2023 is planned. Both have expressed interest in receiving both informal and formal training to further their HR skillset, which is strongly encouraged within Barminco.
- 1 Plant Operator (grader): they have been coached and mentored to adapt their existing plant experience to the underground environment along with training on new underground equipment (Sandvik underground haul truck and Volvo IT).
- 2 Underground Haul Truck Positions: both have been exposed to most of the general mining tasks in the mining cycle (excluding the jumbo, since it's a small crew). The former is currently being upskilled to progress from the underground Haul Truck position to either the All Rounder/Shotcrete operator or the Charge up/Blaster roles.

- 1 Mine Dry Attendant: this entry-level position is specifically given preference for training opportunities for future roles within our stores or the next in line for Underground Haul Truck training.
- 1 Underground Miner: employed in a Charge up/Blaster role (BC certified).
- Mining Engineer: a recent graduate with previous underground mining experience, engaged with the intent to travel to our Australian business to gain further exposure and experience with the specialised underground mining techniques.

Fortnightly meetings are conducted with the TCG Employment and Business Director to ensure first opportunities are being provided to Tahltan members and associates.

If the scope of work at Red Chris is extended to provide suitable tenure to facilitate apprenticeships, it is intended to provide opportunities in multiple disciplines including Heavy Diesel Mechanics, Electrical and Stores.

### DO YOU HAVE ANY TAHLTAN CONTRACTORS WORKING FOR YOUR COMPANY? WHAT ARE THEY DOING ONSITE?

Barminco conducts most aspects of the scope internally. There are Tahltan member-owned businesses that assist with varying needs from time to time, for example, light vehicle transport from Terrace to site and from site to Terrace outside of the Newcrest standard travel days.





Going forward, we are currently investigating the need for a batch plant for the supply of shotcrete for the ground support of the underground development. First preference will be to set this up as a TNDC business opportunity.

There have also been expressions of interest pursued for the transport of our team members to and from the nearby communities that are not currently supported by the Newcrest travel arrangements.

### WHAT IS THE FOCUS OR OUTLOOK FOR THE PARTNERSHIP IN 2023?

The key focus/outlook for the partnership in 2023 is to secure the extension of scope to continue the underground mining service at the Newcrest. Red Chris Mine.

Also, together with TNDC and the Stikine Airport Society, we continue to support the certification and improvement projects for the Dease Lake Airport.

Presently, we do not have any staff members who have self-declared as members of the Tahltan Nation. We have a robust Indigenous Relations Policy and practice to encourage recruitment and development of members of our First Nations and Indigenous staff members such as focussed job placements and recruitment, training programs and grants, and work internship programs. We will continue to improve our processes to ensure we attract, retain and develop Tahltan team members.

### DO YOU HAVE ANY TAHLTAN CONTRACTORS WORKING FOR YOUR COMPANY? WHAT ARE THEY DOING ONSITE?

Not currently directly working for us. TNDC oversees the Airport Services at the Dease Lake Airport which support our charter flight operations.

### WHAT IS THE FOCUS OR OUTLOOK FOR THE PARTNERSHIP IN 2023?

Aviation is a growing industry with exciting opportunities for employment, business partnerships and the development of a unique and in-demand skill set. As such, Our focus is to continue to strengthen our partnership and work collaboratively to meet our shared goals of increased employment and training development in Aviation for members of the Tahltan Nation, increased business opportunities and partnerships, and support for community led projects.

Tahltech Drilling Services Ltd. (Tahltech), is a limited partnership between TNDC and Geotech Drilling Services Ltd. (Geotech). The partnership operates in Tahltan Territory providing multi-disciplinary drilling services for various drilling markets, including:

- · Mineral exploration diamond drilling.
- Geotechnical and environmental drilling.
   Methods include sonic, air rotary, mud rotary, and auger drilling.
- Cone penetration testing (CPT) for tailings facilities and geotechnical assessments through Gregg Drilling and Testing Canada (Gregg), which is majority-owned by Geotech.

Tahltech can utilize various types of drills that are mounted on a variety of drill carriers to drill in almost any location including: track, truck, skid, heli-portable, underground, barge, and amphibious drill carriers.

Typical projects include: mining exploration, pipeline alignments, mine reclamation, mine pit infrastructure design, tailing facility feasibility/upgrades, hydro-electric dam feasibility/upgrades, and more.


We currently employ three full time drillers and a Tahltan-specific exploration industry training program was provided to increase the number of Tahltan employees and further empower those that are currently employed.





# HOW MANY TAHLTANS DO YOU EMPLOY? WHAT LEVEL ARE THEIR POSITIONS? WHAT STEPS ARE BEING TAKEN TO DEVELOP TAHLTAN STAFF AND CAPACITY BUILDING?

To support the site preparation works at the Treaty Creek substation there were typically seven to ten Tahltan members employed on the project at any given time. Positions consisted mainly of operators and labourers. Several pieces of TNDC construction equipment were also utilized on the project.

We are also working closely with TNDC leadership to identify opportunities to integrate candidates into construction management roles on active projects to foster experience.

We hope to see an increase of Tahltan resource utilization when the project recommences in the spring of 2023.

#### DO YOU HAVE ANY TAHLTAN CONTRACTORS WORKING FOR YOUR COMPANY? WHAT ARE THEY DOING ONSITE?


Our team collaborated with Wild Timber, a Tahltan member owned business that specializes in forestry work. Wild Timber and TNDC-DENT crews performed tree clearing works at the Treaty Creek substation. Wild Timber also supported clearing works for the Eskay mine site in late 2021.

#### WHAT IS THE FOCUS OR OUTLOOK FOR THE PARTNERSHIP IN 2023?

TNDC-DENT will continue to focus on heavy civil opportunities to build capacity and provide revenue to the Tahltan community. The team will continue to engage in mining related developments such as Kutcho Copper, Galore Creek, Red Chris, KSM, and Snip mines.

It is anticipated that upon return to the Treaty Creek Substation project in the spring of 2023 that BC Hydro will look to the TNDC-DENT team to deliver additional scopes of work and be heavily involved in the project moving forward.

The partners look to the growth of our collaboration through project execution of civil construction allowing for economic prosperity in the community and job opportunities for members.

Specializing in remote hauling, the majority of our services within Tahltan Territory are provided to the mining and exploration sector, however, we also supply residents, local commercial operations, and the tourism industry.

Our working partnership with TNDC allows us to work together to ensure current fuel service requirements for industry are safely and conscientiously met, and more importantly opens the door for us to find new ways to work together to ensure we are fuelling more than just current industry, but also fuelling opportunities for the Tahltan people.

#### WHAT WERE THE SIGNIFICANT ACHIEVEMENTS OF THE PARTNERSHIP IN 2022?

Our greatest economic achievement of our partnership in 2022 has been the success of retaining the fuelling contract at the Newcrest Red Chris Mine. Not only does this contract ensure the livelihood of many of our own employees, but as a local company, it enables that to ripple to other businesses throughout the northwest.

Our greatest project achievement was our small consulting contribution to the Dease Lake Airport project, which we are really excited to see come to fruition! An airport is a vital asset to a community, and we are confident it will provide great opportunities for economic growth and employment.

Our greatest personal achievement was the safe delivery of our drivers home. Hauling fuel is not easy; our drivers face challenges everyday. Our goal is to mitigate and eliminate risk, and consistently learn and evolve our safety goals and expectations. # HOW MANY TAHLTANS DO YOU EMPLOY? WHAT LEVEL ARE THEIR POSITIONS? WHAT STEPS ARE BEING TAKEN TO DEVELOP TAHLTAN STAFF AND CAPACITY BUILDING?

We do not currently employ any Tahltans, although one quarter of our staff is made up of other First Nations, including Gitxsan, Tsimshian and Nisga'a in management, administrative and driving roles.

We believe one challenge in employing Tahltans is having our head office outside Tahltan Territory, which we are hoping to find ways to circumvent that. Currently, we are looking at ways of working with TNDC to provide Class 1 Driver Training to Tahltans interested in gaining this high-demand skill.

There is a driver shortage across Canada, and the goods and services required by communities and industry are growing. We would love to help facilitate a driver training program that would promote the option for Tahltan members. We are exploring opportunities for "sponsoring and availability" of training both locally and regionally for potential new drivers to achieve their Class 1, options to facilitate the required BC Government (MELT Program) required training for licencing, and funding options for existing employees to upgrade to or train for a Class 1 through WORK BC (to address the cost to achieve a Class 1 license, which can deter many). This is an ongoing effort we hope to see come to fruition in 2023. We will engage TNDC and TCG for input to achieve this.

#### DO YOU HAVE ANY TAHLTAN CONTRACTORS WORKING FOR YOUR COMPANY? WHAT ARE THEY DOING ONSITE?

We do not have any Tahltan Contractors working for our company, as 90% of what we do is handled in-house; although subcontractors are hired as needed. If a contractor is required, we do our utmost to acquire that service locally to the designated job.

#### WHAT IS THE FOCUS OR OUTLOOK FOR THE PARTNERSHIP IN 2023?

For Northwest Fuels, we would like to move into more of a working partnership for driver training. We would love to partner our experiences and expertise to further open doors for the Tahltan people.

We aim to continue to retain and acquire work in Tahltan Territory, with focus on opening up further opportunities for Tahltan employment within our company.

We will aim for open dialogue about ways to improve our contributions to the Tahltan people, lands and communities – with safety for the people and environment being paramount.

We believe we have been a contributing partner to TNDC throughout our partnership, and we very much appreciate the trust given to us to represent the expectations and standards of the Tahltan and TNDC when we travel in Tahltan Territory; our goal is to continue to uphold those to the best of our ability.

#### WHAT WERE THE SIGNIFICANT ACHIEVEMENTS OF THE PARTNERSHIP IN 2022?


Newcrest Mining's Red Chris operation, providing the services referenced above, is our main client, but we are actively engaging other projects in the region.



## WHAT WERE THE SIGNIFICANT ACHIEVEMENTS OF THE PARTNERSHIP IN 2022?

TNDC and Pelly worked together on two major projects: the Newcrest Red Chris Mine tailings impoundment area (TIA) and Seabridge Gold's Coulter Creek Access Road (CCAR). Today, Procon is proud to be recognized as the only mining contractor certified by the Canadian Council for Aboriginal Business (CCAB) as 'Bronze' under their Progressive Aboriginal Relations (PAR) program. Procon's corporate office is located in Burnaby, BC, supported by operating centres in Nisku, AB; Saskatoon, SK; Val-d'Or, QC; and Yellowknife, NT.

#### WHAT IS YOUR RELATIONSHIP WITH TNDC? WHAT SERVICES DO YOU PROVIDE IN TAHLTAN TERRITORY?

Procon and TNDC first partnered in 1998 and have worked together on multiple projects within (or in proximity to) Tahltan Territory – including Barrick's Eskay Creek Mine, AltaGas' Forrest Kerr and McLymont hydroelectric projects, and now Newcrest's Brucejack Mine (previously owned by Pretivm Resources). Our relationship has developed through various forms of joint venture agreements supporting work within the Golden Triangle region of British Columbia for more than 20 years. Services provided include underground mine development, production mining, and underground construction and tunnelling.

#### WHAT WERE THE SIGNIFICANT ACHIEVEMENTS OF THE PARTNERSHIP IN 2022?

Based on 2022 year-to-date performance data, our joint venture is proud to report that:

- Our crews at the Brucejack Mine reached 3,000,000 hours without a Lost Time Incident (LTI).
- Our Brucejack workforce is currently comprised of 17% Indigenous workers.
- Supported and successfully navigated the transition of Brucejack mine ownership from Pretivm to Newcrest during Q1.
- The joint venture paid out more than \$40 million in wages to the crews – contributing significantly to the local, regional and national economies.
- By the end of Q1, Covid related challenges were finally behind us, and our attention turned to mitigating the impacts of inflation on our job costs and margin.
- The Tahltan-Procon JV management committee, supported by HR and Indigenous Relations personnel, launched an initiative to look into career path development opportunities for Tahltan workers. The task force has met twice during 2022 and we will continue to do so during 2023.

# HOW MANY TAHLTANS DO YOU EMPLOY? WHAT LEVEL ARE THEIR POSITIONS? WHAT STEPS ARE BEING TAKEN TO DEVELOP TAHLTAN STAFF AND CAPACITY BUILDING?

As of November 1, 2022, there are currently 20 Tahltans employed with Procon. The positions held by Tahltans include mechanic, miner, and haul truck operator.

Procon has developed an in-house Miner Training Program that incorporates modules to introduce and train workers on various aspects of underground mining. At the Brucejack Mine, new employees from the Tahltan Nation are provided the opportunity to work through these modules over time, with the goal of producing job-ready underground miners. This program combines classroom theory with hands-on training and is aligned with legislative requirements. Through training and experience, the intent of the program is to provide employees with the opportunity to advance over time, and with the right competencies through various job functions, into future roles such as equipment operator, driller or supervisor.

Positions are also made available to those holding technology diplomas/degrees supporting surveyor, mine technician or mine engineering roles within the company. We work directly with TNDC's Human Resources and career centre, and partner to post all job opportunities to TCG's OnTrack Job Board.

As part of Procon's Miner Training Programs, Tahltan members have the opportunity to participate in a wide variety of training courses, including Supervisor & Leadership, New Miner, Equipment, Hazard/Risk, Emergency Response and safety/protection. Procon utilizes project specific Training Plans to identify and communicate training for employees based on their location, hazards and risks specific to their tasks. Procon is committed to providing our current and future Indigenous employees who possess the essential skills and experience with opportunities for advancement. We strive to build relationships that are based upon a foundation of mutual benefit, respect and sustainability

#### DO YOU HAVE ANY TAHLTAN CONTRACTORS WORKING FOR YOUR COMPANY? WHAT ARE THEY DOING ONSITE?

At this time, Procon does not have any Tahltan member-owned businesses working for us; however, we are hoping that opportunities will emerge on future projects. Our Indigenous Procurement Policy was developed in Q4 2021 as a key deliverable of CCAB's PAR certification program; implementation of this policy has helped to ensure that Indigenous businesses across Canada have meaningful access to opportunities within Procon's supply chain. During 2022, Procon's Indigenous spend has grown to 17.75% of our total overall spending, something we are very proud of.

## WHAT IS THE FOCUS OR OUTLOOK FOR THE PARTNERSHIP IN 2023?

It goes without saying that we will continue to focus on providing safe, productive, and reliable underground mining services to our customer, Newcrest, at their Brucejack mine. Our contract will be up for renewal during Q2 of 2023 and we will work collaboratively with Newcrest to address our mutual desire to extend the contract term. We will also be looking for other opportunities within Tahltan Territory to support underground mine development and tunnelling. When commodity prices start to rise again, and economic conditions are supportive, we are expecting there will be considerable resource sector investment in the Territory, which will present our partnership with more opportunities.
