The Tahltan Nation Development Corporation (TNDC) is a business corporation owned by the Tahltan Band, Iskut Band and Tahltan Central Council. TNDC was established in 1985 to enable the Tahltan Nation to fully participate in the economic activities and development occurring within Tahltan traditional territory and to provide employment, training and contracting opportunities to Tahltan members.

TNDC owns and has access to a fleet of heavy equipment that enables the company to carry out a variety of industrial work.

TNDC and its partners provide a full suite of specialized contracting services and supplies for the building construction, forestry, hydroelectric power, mining and road construction industries. RESOURCE DEVELOPMENT IN TAHLTAN TERRITORY

Tahltan traditional territory is located in Northwestern British Columbia. TNDC operations are guided by the *Tahltan Resource Development Policy* and the *1910 Declaration of the Tahltan Tribe*. These documents affirm Tahltan ownership and sovereignty over Tahltan territory and establish guiding principles that resource developers must adhere to when operating within Tahltan territory.



DID YOU KNOW?

Tahltan territory is known as the “golden triangle” due to the abundance of natural resources such as copper, silver and gold.
